City Update/ Council Woman, District 2 Rep. **MariJane Lopez-Taff** After our Council Woman's report, resident, Janie Ricketts commended her for the follow-up regarding cleanup at the mall after last month's concerns were expressed. Council Woman noted the owners were being levied \$1,000 per day to get the property out of blight conditions. MariJane is very immersed in local Boards and Commissions; for the Library, San Juan Parks and Rec District, San Juan School District, Homeless Policy Council, Sac Metro Fire Liaison, and Chamber of Commerce Gov Affairs. 6. Program Presentations:

IMPACT- Police/Crime

Lt William Dunning

Our newly assigned officer, Lt Bill Dunning has been in service 14 years; working Swat, Field, Human Trafficking. He spent 4 yrs as a sergeant and newly promoted to Lieutenant 2 weeks ago. Homeless (per MariJane Taff) numbers Year 2022: 89, this year 2024:62. Retail and auto thefts have increased. Kias and Hyundais are currently the vehicles stolen most often. As previously noted, the CHPD request that all retailers report thefts as it helps keep the statistics updated and ensures assistance is provided where needed. A grant for 90 Flock cameras has been received. These cameras will be placed as recommendations made by the force, Lt Herman and retail needs. They are impressive cameras that gather the vehicle data; plate, color, model etc which help with apprehending suspects, or criminals and the data is sent to RTIC (Real Time Info Center) for quick access. CHPD recently received a "letter of agency" from the City Attorney for businesses to approve/sign which allows the officer to issue a trespassing note on the business's behalf during business closure hours.

Red Cross Disaster and Fire Safety Concerns

Local resident, Patricia, is the Community Disaster Program Manager. Their offices are across from Cal Expo in Sacramento. Her father had been a prisoner of war, that was her motivation for joining this dedicated service for others. As the Red Cross helps unite families separated by war.

Prepare, Respond, Recover: Since its founding by Clara Barton on May 21, 1881, the American Red Cross has been dedicated to humanitarian service to people in need. Born of need on the battlefields in Europe, they also serve the armed forces. They received their first congressional charter in 1900 and to this day they are depended on by federal government to provide early response services to families as well as providing disaster relief in the United States and around the world, although they exist on private donations, not via federal funding.

92% of the responders are volunteers that work 24/7 when catastrophic events occur. Also noted are the enormous number of home fires. In 2023 there were 410 home fires in Sacramento County. Additionally, flooding creates displacement for families. Flood Insurance as well as rental insurance is highly recommended. Red Cross offers literature and references for emergency services etc. We will have a presentation by Metro fire in November.
